## **COACHES PASS & INFORMATION**

- Club Coaches must wear their coach tracksuit and the Provincial or National Coach ID.
- To sit on the chair and be on the tournament floor, all coaches MUST have a coaches pass visible at all times.

## **ATHLETE/ COACH/ PARENT INFORMATION**

- International Athletes, and Coaches must have their own Insurance to participate in the tournament (including USA).
- Parents/Guardians must sign waiver for junior competitors in the signature space provided on the “Club Summary” form.
- By attending and/or registering for the event, you give up the right to sue for any injury or loss to you or to property. If you are a parent or guardian, you give up that right on behalf of your child (ren) and guarantee that no claim will be made.



## **KATA & KUMITE RULES/ REQUIREMENTS**

- WKF rules for all elite divisions and modified KO rules for team sparring and recreational divisions.
- Recreational Kata by flags Elite kata by points with single elimination and sparring will be conducted in full quadral round robin format for divisions with 6 or more athletes. If there are 5 or less athletes, then it will be round robin format.
- Mouth guards, Head gear (under 13yrs), groin protector (optional), knuckle pads, chest guard, shin pad with foot pad are mandatory for all Kumite competitors regardless of age. Glasses are not allowed, exception for proper safety glasses with straps.
- Competitors must wear Protective Equipment that is approved by Provincial, KC, PKF and WKF or same style/design.

## **TEAM SPARRING & TEAM KATA RULES/REQUIREMENTS**

- **Kata:** ALL Team Kata will be single elimination; scored by points.
- **Kumite:** ALL Team Sparring will be single elimination; scored by flags.
- **Penalty:** 1 Yellow Card and 1 Red Card.

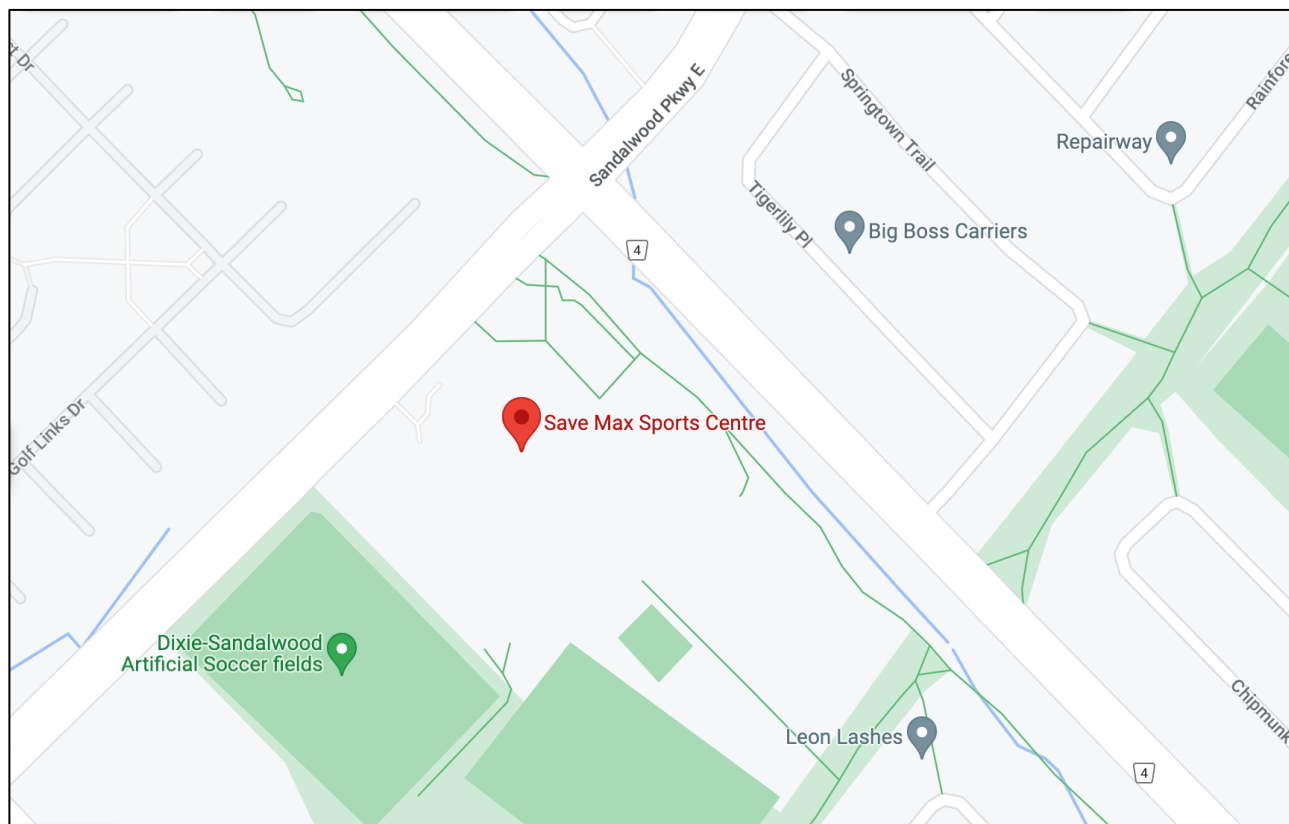
## **REFEREE/ OFFICIAL INFORMATION**
